3. After affiliation with CBSE the school management will ensure that all teaching staff and non teaching staff would pay as per Punjab Government pay scales. In the event of failure to do so the NOC will be cancelled.

4. The management will ensure that due cooperation and information will be provided to DEO and education department of Punjab as well as any senior officer of education department of Punjab.
